OFFICER TAKING REPORT: MAHER, CHRISTOPHER

CASE NARRATIVE

ON 10/14/2013 I WAS DISPATCHED TO 25255 HWY 5 SOUTH IN REFERENCE TO COMMERCIAL BURGLARY. UPON ARRIVAL CONTACT WAS MADE WITH A MS. JERRI L. EASTER(STORE MANAGER). MS. EASTER STATED THAT BETWEEN THE HOURS OF 0130 AND 0945 THIS MORNING SOMEONE BROKE IN THE STORE. MS. EASTER STATED THE SUSPECT LOOKED LIKE AN INDIVIDUAL THAT HANGS AROUND THE STORE ALL THE TIME. MS. EASTER FURTHER STATED THE SUBJECTS NAME IS ANDREW HERRON. I THEN WALKED TO THE REAR OF THE STORE AND NOTICED A LARGE HOLE IN THE WALL THAT WENT OUT TO THE BACK OF THE BUSINESS. WHEN I WALKED TO THE REAR OF THE STORE I NOTICED THAT THE SIDING HAD BEEN PULLED BACK TO GAIN ACCESS TO THE STORE. IT APPEARED TO BE 12 SCREWS MISSING FROM THE SIDING PANEL. MS. EASTER STATED THERE WAS NOTHING TAKEN BUT THAT THE SUBJECT TRIED TO GET INTO THE SAFE IN THE FRONT OF THE STORE AND WAS UNABLE TO DO SO. MS. EASTER STATED THE DISTRICT MANAGER WOULD HAVE TO COME AND MAKE A COPY OF THE VIDEO. OFFICER'S NOTE: I GAVE MS. EASTER THE REPORT NUMBER AND ADVISED HER TO CONTACT CENTRAL DISPATCH TO HAVE AN OFFICER COME GET THE VIDEO WHEN A COPY WAS MADE. CONTACT WAS MADE WITH THE SHIFT SUPERVISOR SGT. MARABLE. SGT MARABLE ADVISED TO CONTACT THE ON CALL DETECTIVE. CONTACT WAS MADE WITH DETECTIVE GARY ROBERTSON WHO ADVISED DETECTIVE RON PARSONS WOULD BE ON HIS WAY TO THE SCENE. THE SCENE WAS TURNED OVER TO DETECTIVE PARSONS UPON HIS ARRIVAL.
